This donation will be used to purchase technological equipment and materials. Your generosity greatly aids us in our endeavors to meet the technology instruction of Brogden Middle School's students.

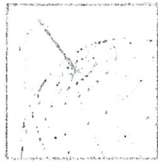

## STATEMENT OF TAX EMEMPT STATUS

The Durham Public Schools' Board of Education Agency empowered by Chapter 115C of the North Carolina General Statues with the responsibility to oversee and control all activities related to public school education in Durham County, North Carolina. The school system qualifies as a governmental entity and is exempt from federal and state income taxes. The Board receives local, state, and federal government funding and must adhere to the legal requirement of each funding entity. Durham Public School is recognized as having tax-exempt status according to section 115 of the Internal Revenue Code.

Contributions made payable to Durham Public Schools are deductible by donors as provided under section 170 of the Internal Revenue Code, if the contribution or gift is made exclusively for public purposes.
